## **Recent Considerations:**

# CAC:

A new task was assigned by PSC for the study of Youth in Contesting category or awards. CAC has discussed with little feedback from membership in support so far.

We received a notice of a petition to move the Field Day date for health and safety concerns. Petition has not been formally received. Some discussion has taken place regarding this subject with little support for change.

Suggestion was made by an ARRL member to add a "Limited Antenna" category to all HF contests. CAC is discussing this.

The CAC is evaluating the new Digital Contest. So far, we have noted good participation and nice comments from the community. We are looking for any constructive ideas. One suggestion was to create a Technician category to improve the 10 and 6 meter activity.

# **VHF Subcommittee/CAC:**

The June VHF was the first one to implement the Analog category. Many entries were received in this new category. Less negative 3830 comments were noted from previous years. However, propagation was favorable compared to the last couple of years and that may have had some impact. The VHF subcommittee is studying the results.

The VHF subcommittee has met several times and currently is discussing ideas regarding the January, June, and September VHF contests. Goal is to improve and attract activity. The VHF committee reports their work to the CAC on a regular basis.
